Accredited 8 youth corps who served 1,695 young people

CONTRACT COORDINATION AND MANAGEMENT

- Developed and distributed \$3.45 mil in funds for youth employment and training
- Managed 2 AmeriCorps grants for young adults and military veterans earning stipends for conservation service statewide: YCCO for \$1.18 mil and CCC for \$1.1 mil.

YOUTH SCHOLARSHIPS FOR COLLEGE AND TRADE SCHOOLS

CYCA and youth corps have distributed over \$1.26 mil in AmeriCorps Education Awards to 549 young adults and veterans statewide. Many of these vouchers support tuition at Colorado colleges or reduce existing student loan debt of participants.

STRATEGIC COMMUNICATION

CYCA engaged in strategic communication on behalf of corps. This communication includes conducting presentations at state and national conferences, to statewide boards and commissions, and testifying before elected officials and conservation decision-makers.
